-Strategic Planning

-Teacher Appreciation

Lot of interest on Board on ways to recognize teachers and ASD staff, esp. in pandemic. Working with Superintendent to find ways to do that.

-Other

Discussion:

Wed. March 3, 8:30-8:45

Theme: *Virtual Reality 2021*. No current teachers and students because they have their hands full. Retrospect 2001-2019. Working with videographer, Jon Mulder, 3Seed Marketing.

Last year Gala made \$140,000. ASDF kept \$114,000.

This year goal of \$80. City Center and Gallagher have already pledged, so now at \$4500. Asking everyone to solicit or give Sue leads for \$1,000-5000. March 15 deadline for Sponsorships.

Questions:

Angela asked about whether to accept credit cards on the sponsorships. Sue will readjust. Tonya suggested Venmo and Zello (in chat)

Tonya asked if students are doing music programs at school. Josh said Yes.

Sue assured teachers that we would uphold our grants for music programs

Tonya asked if a theatrical performance from last fall could be included. Could we have a live segment or a pre-recorded piece to highlight some part of this school year?

Don suggested excerpts from past Allen and Dieruff shows, not just Gala performances.

Question of length of program. Can it be more than 15 minutes? Inhibited by cost.

Sue will look into these issues. Dan welcomed more questions and suggestions after the meeting.

Topic and Presenter: Administrator Report Vicki Newhard

Discussion:

Encourage people to contribute through PayPal, rather than credit card.

-EITC Update

Major source of income: Currently, \$40750 from 9 business. Last year YTD \$48,250. Usually receive about \$75,000/year

Have submitted Program Report and renewal application so can continue to be listed as EITC approved organization.

-Annual Appeal Update

YTD \$31.460, down by a few thousand. Last year, YTD, we were at \$39,321. Usually \$44,000-45,000/yr.

Other Business:

Josh Dodd: First PPP loan paid off by SBA in its entirety. We were down 25% in income so allowed to apply for another loan of \$21,200. Approved by bank and sent on for final approval.

Finance Committee will meet Feb 25. Need new signers with new Ex Dir and Sec. Rob Schmidt is head of the Investments committee.

Question for Nancy Wilt (as President of School Board): Is there a search committee yet for Superintendent? Not yet. Working on it and want to do it right.

Mike recommend that School Board appoint a rep from ASDF Bd to the search committee: Dan or Tonya

Dan will send a formal request to have an ASDF Bd member on search committee
